The elective may be used for an Internship, Study Tour or Individual Study in Business. The Internship requires a GPA credit average and approval from the Program Director.

The Study Tour requires approval from the Program Director. The Individual Study in Business is only available in exceptional circumstances and requires the Program Directors approval.

### **GENERAL INFORMATION**

The BBT Global Leadership MBA provides a flexible and adaptive learning environment for students to enhance their skills and develop as global leaders. The program offers a combination of online and residential immersion experiences, with subjects in English (with options for some in Japanese). The focus is on allowing participants to develop effective and informed decision-making frameworks to think critically, to act and lead strategically, and to understand the importance of an innovative and entrepreneurial mindset.
