

# How to acknowledge GAI in a Negotiated Assessment Task

A [Statement of Authorship](#) must be included with every submitted assessable piece of work. For transparency, you may choose to add a written statement which details your use of Generative Artificial Intelligence (GAI) software. You do not have to include a written statement unless instructed by your educator.

If you have individually negotiated GAI use or have a negotiated assessment task, the following sample statements may be of use. You might also like to use [the six-step GAI template](#). Feel free to adapt them to reflect your assessment and use of GAI. Please approach the use of GAI with caution, recognising both its risks and the opportunities for learning.

## Example 1: Initial scoping

I declare that I am the author of this assessment. I requested and gained written permission from my educator to utilise Generative Artificial Intelligence (GAI) in this assessment submission. I acknowledge the use of GAI tools \_\_\_\_\_ (for example ChatGPT, QuillBot; Google Bard; beautiful.ai) in the initial scoping of this topic. This information was used to inform the creation of this assessment. Additional source material was used to both validate and expand upon the initial information provided by GAI tools. All additional source materials used in the creation of this submission are included and detailed in the reference list provided.

## Example 2: Initial literature review

I declare that I am the author of this assessment. I requested and gained written permission from my educator to utilise GAI tools \_\_\_\_\_ (for example ChatGPT, QuillBot; beautiful.ai) in the preparation and creation of this assessment submission. GAI tools were used in the completion of an initial literature review on the topic. Acknowledging the limitations of artificially generated information, the content was analysed, and sources were evaluated to ensure the validity of the information generated by GAI tools, with several errors identified. All additional source materials used in the creation of this submission are included and detailed in the reference list provided.

## Example 3: Writing specific parts of the assessment

I declare that I am the author of this assessment. I requested and gained written permission from my educator to utilise GAI tools \_\_\_\_\_ (for example ChatGPT, QuillBot; CoPilot; beautiful.ai) in the preparation and creation of this assessment submission. Artificial intelligence tools were used in the completion of an initial literature review on the topic. GAI tools were used to support the writing of both the introduction and conclusion of this assessment task. Acknowledging the limitations of artificially generated information, the content was analysed, and sources were evaluated to ensure the validity of the information generated by GAI tools, with several errors identified. All additional source materials used in the creation of this submission are included and detailed in the reference list provided.
