

## **Coronavirus COVID-19: Mandatory Student Screening Form**

Students who have been approved to commence placement at Ramsay Health Care are required to complete the following details at orientation, if not completed prior.

The following questions are mandatory to determine your current level of risk associated with COVID-19, and outline precautions to reduce the risk to you, our staff and our patients.

Have you returned from overseas in the past 7 days?		
Have you been in mandatory isolation in the past 14 days?		
Have you been identified as a close household contact of a confirmed		
COVID case in the last 7 days?		
Have you been tested for COVID and are currently waiting the result?		
Have you been diagnosed in the past 10 days as a confirmed COVID		
positive case?		
Do you currently work in a Health Care or Residential Aged Care setting		
with a confirmed COVID outbreak in the last 14 days, or plan to		
commence work at one of these settings during this clinical placement		
period? This includes paid work or on a student placement.		
Are you currently unwell with any cold or flu-like symptoms (including		
but not limited to, fever, cough, sore throat, shortness of breath, loss of		
taste or smell, vomiting or diarrhoea)?		
Are you unvaccinated for COVID-19?		
Are you unvaccinated for this year's seasonal influenza?		
(Recommended for all students and required in Victoria for all students		
in RHC facilities)

If you answered 'Yes' to any of the above, please advise the State Student Placement Coordinator immediately.

If students develop COVID or influenza related symptoms they should notify their educator and Education Provider, self-isolate and seek testing immediately and remain isolated until negative results are received. Send your results to your educator and education provider.

It is recommended that students do not work across multiple facilities. If a student does work at another facility such as residential aged care during their placement, they may be required to wear a respirator mask while on placement and may be subject to routine asymptomatic surveillance RAT for the duration of their placement.

## Risk assessment should consider:

- If they have any family/household members who are unwell or family/household members who are isolating as they have been identified as close contacts
- If they are seeing and treating vulnerable patients
- If they are participating in the care of patients undergoing an aerosol generating procedure. If so, they must be fit tested for a P2/N95 respirator mask

## Students should be advised to:

- complete the screening requirements on arrival at the facility
- strictly maintain social distancing
- adhere to jurisdictional movement and gathering restrictions
- monitor their health for any symptoms
- be immediately tested if they have any symptoms
- be vaccinated against COVID-19 and be up-to-date with recommended boosters for COVID-19
